Must be Attached to Rebate Form:

- 1. Copy of Original Paid Receipt. Proof of purchase must include the customer name, address, and date the service was completed.
- 2. Copy of permit, if applicable.
- 3. Serial Number of Unit.
- 4. Rebate form must be received by the City of Leesburg Electric Department within **90 days** of the Permit issue date.
- 5. Customer signed Terms and Conditions of the Rebate Form.

Rebates may take between 4-8 weeks (2-3 billing cycles) for processing. Rebates will be in the form of a credit on one or more of the customer's City of Leesburg electric utility bills for the address listed on the invoice. In the event that a qualifying customer is in default of any payment obligations to City of Leesburg, Leesburg may, in its sole discretion, apply the rebate as a credit against such default amounts.

Application and Additional Terms and Conditions of the Rebate

Application:

- An original customer signed application for a rebate must be completed by the customer or contractor and approved by the City of Leesburg Electric Department.
- The rebate form must be mailed or delivered to the City of Leesburg Electric Department within 90 days of the permit issued date.
- A copy of the customer's paid invoice must be attached and include the customer's name, address, and date of purchase.
- A copy of the AHRI Certificate (Certificate of Product Ratings) must be attached.

Additional Terms: Rebate Credit

The City of Leesburg (Leesburg) reserves the right to:

- Withhold payment of any rebate until any identified problems with the applications are resolved.
- Terminate this rebate in whole or in part due to the recipient's failure to fulfill the terms and conditions in this document, or due to non-appropriation of necessary funds.
- Alter and/or terminate the rebate program at any time and without notice to the customer or contractors.
- All rebates are subject to funding availability. Leesburg may cancel a rebate at any time prior to payment, without notice, due to lack of available funds.
- Rebates will be in the form of a credit on one or more of the customer's electric utility bill for the address listed on the invoice. In no event shall any rebate credit on a monthly customer bill exceed the amount owed by customer. In the event that a qualifying customer is in default of any payment obligations to Leesburg, Leesburg may, in its sole discretion, apply the rebate as a credit against such default amounts.

Limit of Liability: Indemnification

- In no way shall Leesburg be liable for, and Customer hereby agrees to indemnify, defend and hold harmless Leesburg, its subsidiaries or affiliates, and their respective employees, officers, and directors, from and against any and all liability, loss, damage, cost or expense, including attorney's fees, that may be caused by, due to, occasioned by, or

otherwise arising out of the installation, operation, mis-operation, or use of Customer's Qualifying Energy Efficient Equipment.

- Customer acknowledges and agrees that in no event shall any statement, representation, or lack thereof, either express or implied, by Leesburg, relieve the Customer of exclusive responsibility for the Customer's system. Specifically, Leesburg's approval of the rebate application, payment of the rebate, or any Leesburg inspection of the Qualifying Energy Efficient Equipment shall not be construed as confirming or endorsing the system design or its operating or maintenance procedures nor as a warranty or guarantee as to the safety, reliability, or durability of the Qualifying Energy Efficient Equipment.

Customer Qualifications:

Form may be completed by Contractor or Customer and must be reviewed and signed by the customer of record and submitted within 90 days of permit date. Rebate is subject to approval, is contingent upon availability of funds and may be discontinued without prior notification. Onsite verification may be required. In the event that a customer is in default of any payment obligation to the City of Leesburg, Leesburg may apply the rebate as a credit against such default amounts.

By participating in this program, customer agrees that the City of Leesburg shall have the sole right to obtain and retain ownership of, and to qualify for and receive the full benefit of, any and all existing and future credits, certificates, benefits, environmental attributes, emissions reductions, offsets and/or allowances, however entitled, attributable to the purchase, installation and/or operation of the above rebates.
