

**ADDENDUM TO**  
**INTERLOCAL AGREEMENT BETWEEN**  
**LAKE COUNTY, FLORIDA AND**  
**THE CITY OF LEESBURG FOR**  
**COMMUNITY BENEFIT ORGANIZATIONS FOR THE**  
**NEIGHBORHOOD STABILIZATION PROGRAM**  
**RFP 09-0218**

This is an Addendum to Interlocal Agreement between Lake County, Florida, a political subdivision of the State of Florida, hereinafter referred to as the COUNTY, by and through its Board of County Commissioners, and the City of Leesburg, a Florida municipality, its successors and assigns, hereinafter referred to as CONSULTANT or Community Benefit Organization (CBO).

**Recitals**

**WHEREAS**, the parties did enter into an Interlocal Agreement under Request for Proposal (RFP), #09-0218 for the purposes of retaining multiple Community Benefit Organizations (CBO) that are qualified and have capacity to provide the acquisition, repair, rehabilitation and resell of foreclosed and abandoned properties and/or the redevelopment and management of rental properties which are anticipated for the implementation of the Neighborhood Stabilization Program; and

**WHEREAS**, the COUNTY and the CONSULTANT now desire to enter into this Addendum to provide for additional services as additional money is available through the NSP1 Program.

**NOW, THEREFORE, IN CONSIDERATION** of the mutual terms, understandings, conditions, promises, covenants, and payment hereinafter set forth, and intending to be legally bound, the parties hereby agree as follows:

**1.1** The foregoing recitals are true and correct and incorporated herein by reference.

**1.2** As additional money is available under the NSP1 Program, the parties hereby agree that the original Interlocal Agreement shall be amended to allot to the CONSULTANT the following total funding:

Amount:	\$149,316.94
Max amount on one home:	\$149,316.94
Number of Properties:	Minimum of one (1) property for resale or rental
Extended Time:	January 31, 2014

**1.3** All other provisions of the original Interlocal Agreement shall remain in full force and effect unless otherwise amended by the parties.
